# COST INFORMATION

**The cost is \$10.50 per person (including chaperones); there is no charge for teachers.**

Minimum charges apply and are noted below. A deposit is applied to the total cost. However if a group cancels or does not fulfill their contract the deposit is forfeited.

**EXCLUSIVE** \_\_\_\_\_ For schools of 300 (minimum) to 400 (maximum) people. The park is reserved exclusively for your group. The minimum rate is \$3,150 and a \$300 deposit is required to reserve your spot.

**SHARE PLAN** \_\_\_\_\_ For schools smaller than 300 people, you will be sharing the park with other guests. The following minimums apply, and a \$200 deposit is required to reserve your spot.

### In which category do I fall?

Please mark the category which most accurately defines the number of people in your group.

### What does the minimum cost mean?

The minimum cost simply indicates the amount you will be required to pay if you have less than the numbers you select. The cost remains \$10.50 a person except in the situation that you do not have as many people as you expected, in which case it would be more than \$10.50.

### What if I don't reach the min. # of people?

If you realize that you are not going to have the minimum number of people that you selected, you may want to consider these options:

- Inform your group that it will cost more than \$10.50 per person or you may choose to simply cover the difference.
- Encourage parents to attend along with their children to increase the number attending.

### What if I have more students/parents than I anticipated?

Call Antietam Recreation immediately to see if space is available. If it is, make the addition to your count.
